



## FEES AND CHARGES IN RESPECT OF THE MUNICIPAL CEMETERIES AND CREMATORIA WITH EFFECT FROM 1 APRIL 2021

Birmingham City Council has reviewed its fee structure for its Bereavement Services and wishes to invite views on the proposals. The reasons for the review of fees are as follows:-

- An annual review ensures fees are appropriate taking into account the costs of providing the service;
- Revised fees/ charges can be made if the service offer has changed;
- For bereavement services it is necessary to ensure the fees and charges are competitive with the market place;
- There is the opportunity to simplify the fees and charges.

This year these fees and charges have on the whole remain unchanged in recognition of the national and local economy, although where there is the opportunity to reduce fees this has been undertaken. In these fees and charges the summary of changes shows:-
