CREMATION FEES

The fees detailed below include the use of the chapel, scattering of cremated remains in the Garden of Remembrance (no witness), Medical Referee's and (if required) use of organ and/or provision of recorded/Wesley music.

Webcasting, personal tributes and recordings of services available at additional cost – price on application (POA)

Where a cremation service takes place for two adults one of the cremation fees will be reduced by the use of chapel fee.

CEMETERY FEES

Exclusive Right of Burial (ERB)

Earthen graves and walled graves/vaults have an Exclusive Right of Burial for a period of 75 or 99 years, with the option to renew such Rights on the terms then prevailing for a similar Grant. This fee also includes the right to place and maintain a memorial on the grave. Such rights to expire co-terminus with the Exclusive Right of Burial.

Burial Rights will not be regarded as pre-purchased if the first person to be interred died before or within 14 days of application being made for the purchase of such rights.

Children's Funeral Fund

* The government introduced the Children's Funeral Fund in 2019 which applies where the child who died was under the age of 18 or was stillborn after 24 weeks of pregnancy. This fund allows Birmingham City Council to claim all fees for the burial so families will not be charged for burial/cremation services.

INTERMENTS

(Maximum 1 hour appointment allocation per booking - ½ hr for items 7a - 7c).

N.B. Maximum coffin width in a standard grave is 30" in width including a re-opened or pre-purchased grave. In the event that the coffin/casket exceeds 30" then prior approval is required from the cemetery office to query if the size of the casket can be accommodated.

5. Graves (Including public graves)

a	Adult Interment of a person aged 19 years or over. For single depth or second interment in double depth grave.	£1,320
b	Adult Interment of a person aged 19 years or over. For the first interment in a double depth grave.	£1,430
c	Child Interment of a still born child. This includes non-viable foetal remains or a child aged 18 years or below. * NB. The size of grave will be determined by the size of the coffin. If the coffin exceeds the size of 3'6 x 2'6 an adult grave will be allocated, and the fees listed at 5a will apply.	£180.40*

a	Scattering of cremated remains on a grave when cremation did not take place at a Birmingham City Council Crematorium. The fee to witness the scattering of cremated remains is included.	£121
b	Witness scattering of cremated remains on a grave when cremation took place at a Birmingham City Council Crematorium. Where multiple scatterings take place on the same grave at the same time, this fee will only be applied once.	£60.50

13. Transfer Fee[#]

a	Transfer of ownership and subsequent registering of an existing Exclusive Right of Burial where the owner of the Exclusive Right of Burial is deceased, and a burial is to take place or where the transfer is to a resident of Birmingham. *An additional 30% of the original purchase fee will be applied where the transfer is taking place to a person who is not a resident of Birmingham (This is not applicable when the applicant is the only surviving next of kin of the deceased registered owner.	£82.50

15. Service

a	Where a burial service takes longer than 1.15 hours from the appointed service time an additional fee will be applied – Charge will be applied for each half hour over and above the 1.15 hours.	£308
b	Where the service for an interment of cremated remains takes longer than 30 minutes from the appointed service time an additional fee will be applied. – Charge will be applied for each half hour over and above the 30 minutes.	£88

a	Late cancellation of funeral booking (after 10.00 hours on the working day prior to the funeral – except for short notice bookings made on the day of the funeral).	£302.50
b	Late cancellation / non-attendance for booking of cremated remains interment (after 10.00 hours on the working day prior to the funeral).	£66
c	Late cancellation / non-attendance for booking of scattering of cremated remains.	£27.50

a	Use of Handsworth Cemetery chapel including use of organ and, if required, provision of recorded music.	£352
